

- 1. The People's Republic of Bangladesh has received a Credit (66760 BD) from the International Development Association (IDA) of the World Bank for the Implementation of Private Investment and Digital Entrepreneurship (PRIDE) Project. The project will be implemented by BEZA and BHTPA. Economic Relations Division (ERD) of Ministry of Finance (MoF) has been given the responsibility to play coordinating role to ensure smooth operation of the project. A project named Central Coordination Unit of Private Investment and Digital Entrepreneurship (CCU-PRIDE) has been approved for coordinating purpose. A part of Credit of CCU-PRIDE project will be utilized for payment of individual Junior Consultant who will provide technical inputs relating to accounts and financial issues for the effective execution of the project.
